MINUTES OF MEETING BOARD OF COUNTY COMMISSIONERS OF SARPY COUNTY, NEBRASKA

A meeting of the Board of County Commissioners of Sarpy County, Nebraska was convened in open and public session at 7:00 p.m on February 25, 1997 at the Courthouse in Papillion, Nebraska. Present: Thomas O'Hara, Tim Gay, Bart Bonn, Don Knott Sr., Tim Schram, Board Administrator Mark Wayne and Debra J. Houghtaling, County Clerk.

Notice of the meeting was given in advance thereto by publication in the Bellevue Leader on February 19, 1997, a copy of the Proof of Publication is on file in the County Clerk's office. Notice of the meeting was simultaneously given to all members of the Board of County Commissioners of Sarpy County, Nebraska. Resolved as amended by Bonn, seconded by Knott, that the Sarpy County Sheriff is hereby requested to review the security of the Sarpy County courthouse and make recommendations to this Board, through Building and Grounds Committee, to any additional security measures, if any, that may be necessary. Bonn moved, seconded by O'Hara, to table agenda item #11-3 (Res: Budget transfer for Courthouse security) requesting the Fiscal Administrator and Sheriff to provide figures on the cost of the additional security measures. The Fiscal Administrator shall place this item on the agenda at a later date. Ayes: O'Hara, Gay, Knott, Bonn & Schram. Nays: None.

Legislative bills of interest to Sarpy County currently before the 1997 Session of the Nebraska State Legislature were discussed.

Resolved by O'Hara, seconded by Gay, that this Board hereby opposes the passage of LB 99, as introduced, which would eliminate a revenue source (bingo tax) and increase an existing tax on Sarpy County (tax on Keno operation) without providing any replacement revenues. Ayes: O'Hara, Gay, Bonn & Schram. Nays: None.

Resolved by Gay, seconded by Knott, that this Board hereby opposes the passage of LB 101, as introduced, which would eliminate Sarpy County's authority to operate a Keno game. Ayes: O'Hara, Gay, Knott & Schram. Nays: None. Absent: Bonn.

Resolved by Gay, seconded by O'Hara, that this Board hereby supports the passage of LB 281, as introduced, which would increase Sheriff's fees for serving and returning summons, subpoenas and various other orders and notices. Ayes: O'Hara, Gay, Knott, Bonn & Schram. Nays: None.

The Board declined action on agenda items #12-4 (Res: LB 507 - Consolidation of Clk. of Dist. Court & Clerk Magistrate Co. Court) and #12-5 (Res: LB507/817 - State takeover of Clerk of District Court). The Board will continue to monitor these legislative bills.

Resolved by Knott, seconded by Gay, that this Board hereby supports the passage of LB 841, as introduced, which would provide that the cost of medical services for prisoners shall be paid by the prisoner's insurance, the prisoner, or any other available sources rather than from County property tax dollars. Ayes: O'Hara, Gay, Knott, Bonn & Schram. Nays: None.

Bids for grading and concrete pavement for Chandler Road between CenTech Business Park and existing Chandler Road in Chalco Valley, Sarpy County Project No. C77(97-15), have been solicited, made, opened and reviewed pursuant to applicable Nebraska State Statute.

After a public hearing, Knott resolved, seconded by O'Hara, that the bid of Anderson Construction for grading and concrete pavement for Chandler Road between CenTech Business Park and existing Chandler Road in Chalco Valley, Sarpy County Project No. C77(97-15) in the amount of \$44,527.20 is accepted, per written and oral recommendation of the Purchasing Department, and this Board's Chairman, Clerk and Attorney are authorized to execute necessary documents.
