

Sanitary and Improvement District Elections

Election Day is Tuesday, September 14, 2010.

Filing deadline is July 26, 2010 (fifty days prior to the election). Applications may be obtained from the Election Commissioner's office and may be notarized by a Notary Public and returned to the election office by July 26 at 5:00 P.M. Filings are also taken in person at the Election Office. No filing fee is required. When filing, the candidate shall designate on which ballot their name shall appear. The name shall appear on only one ballot.

Write-in candidates may be elected to office, however, the box appearing in front of the write-in name must also be marked. Such trustees shall be owners of real estate located in the district or a designated representative of an entity that owns real estate in the district.

*If the name of the person filing does not appear first on the deed, verification of property must be presented at the time of filing.

**For a designated representative of a limited partnership, general partnership, limited liability company, public, private, or municipal corporation, estate, or trust which owns real estate in the district, the filing shall indicate that fact and shall include appropriate documentation evidencing such fact.
